NARRATIVE REPORT – 2023

Institution history

“Education” Public Support Association of Youth of Azerbaijan (EPSAYA) public union was established on March 31, 2005 in Lankaran with the initiative of common interests for the purposes of combining local educated youth as a non-political, voluntary, self-governing and non-governmental organization.

The public union was registered by the Department of the State Registration of Juridical Persons of the Ministry of Justice on May 31, 2005.

Sphere of activity of the public union covers the territory of the Azerbaijan Republic.

Goal and objectives

The main goal and mission of the public union is to educate and inform the youth and by the means of the youth in society about the social, economical, legal, environmental and other fields.

The main objectives of the public union are to assist in implementing the community-scientific knowledge through realizing the educational system of measures among the youth and the general public through different events (trainings and seminars, debates and clubs, round-tables and meetings, circles and courses, conferences and exhibitions, charity marathons and the other cultural and mass events).
